

Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to www.ambrosialasvegas.com, and Ambrosia Cafe and Bar and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to Ambrosia Cafe and Bar include www.ambrosialasvegas.com. The Ambrosia Cafe and Bar website is a restaurant website site. By using the Ambrosia Cafe and Bar website, you consent to the data practices described in this statement.

Collection of your Personal Information

In order to better provide you with products and services offered, Ambrosia Cafe and Bar may collect personally identifiable information, such as your:

- First and Last Name
- Mailing Address
- E-mail Address
- Phone Number

Ambrosia Cafe and Bar may also collect anonymous demographic information, which is not unique to you, such as your:

- Age
- Gender

We do not collect any personal information about you unless you voluntarily provide it to us. However, you may be required to provide certain personal information to us when you elect to use certain products or services. Use of your Personal Information

Sharing Information with Third Parties

Ambrosia Cafe and Bar does not sell, rent or lease its customer lists to third parties.

Ambrosia Cafe and Bar may share data with trusted partners to help perform statistical analysis, send you email or postal mail, provide customer support, or arrange for deliveries. All such third parties are prohibited from using your personal information except to provide these services to Ambrosia Cafe and Bar, and they are required to maintain the confidentiality of your information.

Ambrosia Cafe and Bar may disclose your personal information, without notice, if required to do so by law or in the good faith belief that such action is necessary to: (a) conform to the edicts of the law or comply with legal process served on Ambrosia Cafe and Bar or the site; (b) protect and defend the rights or property of Ambrosia Cafe and Bar; and/or (c) act under exigent circumstances to protect the personal safety of users of Ambrosia Cafe and Bar, or the public.

Tracking User Behavior

Automatically Collected Information

Right to Deletion

- Detect security incidents, protect against malicious, deceptive, fraudulent, or illegal activity; or prosecute those responsible for that activity;

- Debug to identify and repair errors that impair existing intended functionality;
- Exercise free speech, ensure the right of another consumer to exercise his or her right of free speech, or exercise another right provided for by law;
- Comply with the California Electronic Communications Privacy Act;
- Engage in public or peer-reviewed scientific, historical, or statistical research in the public interest that adheres to all other applicable ethics and privacy laws, when our deletion of the information is likely to render impossible or seriously impair the achievement of such research, provided we have obtained your informed consent;
- Enable solely internal uses that are reasonably aligned with your expectations based on your relationship with us;
- Comply with an existing legal obligation; or
- Otherwise use your personal information, internally, in a lawful manner that is compatible with the context in which you provided the information.

Children Under Thirteen
